December 5, 2018

Ontario City Council met in regular session on December 5, 2018, in the Municipal Building, with Council President Jim Hellinger presiding. The meeting opened at 7:00 p.m. with a moment of silence for the passing of former President George H. W. Bush, followed by the Pledge of Allegiance.

Present during roll call were Council members Ken Earhart, Larry Arnold, Eddie Gallo, Dan Zeiter, Mark Weidemyre, Council President Jim Hellinger, Mayor Randy Hutchinson, Law Director Andrew Medwid, Service-Safety Director Jeff Wilson and Clerk of Council Cathy VanAuker.

Mr. Arnold moved to excuse Mrs. Webb and Mr. Sunderland from this evening's meeting, second by Mr. Earhart. Five members cast their votes Aye, zero Nay and the motion passed.

The minutes of the regular Council meeting of November 20, 2018 were presented for approval. Mr. Zeiter moved to approve the minutes, second by Mr. Gallo. Four members cast their votes Aye, one Abstain by Mr. Arnold, zero Nay, and the motion passed.
