### Job Duties and Responsibilities:

- Responsible for the safe and efficient operation of the Water Plant, wells, pumps, and water storage tanks.
- Certified to perform daily laboratory testing of chlorine, fluoride, hardness and bacteria, as required by law.
- To make a budget for all materials, labors and equipment necessary to pump and treat the water to standards set by the OEPA.
- Submit Monthly Operating Report to the Ohio EPA, as required by law.
- Submit the annual Well Flow Log to ODNR, as required by law.
- Maintain and update the EPA Emergency Contingency Plan, as required by law.
- Maintain a Back Flow Prevention Program as required by the Ohio EPA.
- Follow the Lead and Copper rules as required by the Ohio EPA.
- Coordinate with OUPS prior to water line repairs.

- Makes sure that all current rules and regulations for the Ontario Water System are followed.
- Monitor and inspect all contractor installation of waterlines for developers of Industrial, Commercial, and Housing developments.
- To consult with the Service-Safety Director as to all major renovations and/or repairs.
- Must have the capability to use hand tools such as a shovel, pick, hammer, screwdriver, drill, etc.
- Must have the ability to learn to operate heavy equipment such as: dump trucks, back hoes, mowers, chipper, leaf vacuums, snowplow, and any other equipment used to maintain the City.
- Must be able to work well with other employees, follow directions, and practice safe work habits.
- Must have or attain within 12 months of employment a commercial driver's license with air brake endorsement.
- Must take proper care of equipment and tools.
- Follow all safety rules and regulations and safe work practices.
- Keeps informed of City policies and procedures.
- Must possess and maintain valid Ohio driver's license.
- Maintain regular and predictable attendance.
- Performs any other related duties as required.

#### Requirements

- A high school diploma or equivalent is required.
- Must have experience in public works and related construction, maintenance and repair, or any equivalent combination of experience and training which provides the desired knowledge, skills and abilities.
- Must have and maintain a Class 2 Water Supply License.

### Inherently Hazardous or Physically Demanding Working Conditions

- Employee is occasionally exposed to dangerous chemicals (i.e. salt, Potassium Permanganate, Chlorine, Hydro Flouro Silicic Acid) and any other job-related hazardous materials.
- Employee works with and around motorized equipment, hand and power tools; works with and around chemicals and liquid fuels; works under adverse weather conditions; is exposed to dust, dirt, and fumes; is exposed to noise and traffic; may occasionally lift and move heavy objects.
- In accordance with the U.S. Department of Labor physical demands strength ratings, this is considered very heavy work.
