Ontario City Council met in regular session on February 1, 2023, in the Municipal Building with Council President Eddie Gallo presiding. The meeting opened at 7:09 p.m., with the Pledge of Allegiance.

Present during roll call were Council members Troy Sapp, Dave Rehfeldt, Kyle Webb, Sherry Branham, Rose Feagin, Nathan Sunderland, Council President Eddie Gallo, Mayor Randy Hutchinson, Law Director Andrew Medwid, Service-Safety Director Kris Knapp, Zoning Inspector Michael Morton, and Clerk of Council Cathy VanAuker.

The minutes of the regular Council meeting of January 18, 2023 were presented for approval. Hearing no corrections, the minutes were approved as presented.

COMMITTEE REPORTS

Mr. Webb announced a Utilities Committee meeting on March 1, 2023 at 6:00 p.m.

Ms. Branham called an Economic Development Committee meeting on February 15, 2023 at 5:30 p.m.

Ms. Branham reported the Personnel Committee met earlier this evening to discuss changing the allowable time for employees to report required personal changes from 5 days to 10 days, the request for changing the Deputy Auditor position from part-time to full-time, two individuals preparing to test for the Class 2 Water License, and a post-accident policy will be prepared to discuss at the next meeting. A Personnel Committee of the Whole meeting will be held on March 15, 2023, at 5:30 p.m.

Ms. Feagin said the Streets Committee met this evening, where they made a recommendation to hire a company to assess the city streets and prepare the paving list for about \$4,000 per year. Other discussion topics included sidewalks, and the possibility of receiving approximately \$250,000 in federal funding for an Ontario sign on the St Rt 30 bridge.

Mr. Sunderland said approximately 95% of the residents he spoke with in his Ward expressed their appreciation toward the Streets Department on how well they maintained the streets during the winter weather. Their hard work is being noticed.

At this time, President Gallo changed the order of the agenda to address legislation before Mr. Sunderland needed excused from the meeting.

RESOLUTION NO. 23-05

- 1. The residential Gas Aggregation contract price is \$0.618, which will begin in May.
- 2. The Parks Foreman and Supervisor are making a plan to improve the walking path and extend the trail down the hill. They also discussed the lighting in the park, upgrades to the splash pad, mulch, and upgrading the lights for the Christmas Tree lighting.
- 3. The sidewalk project, Resolution 23-05, is the ODOT approved sidewalk that will go from the school to Pearl Street. The city is required to take care of the additions at the edges of the sidewalk at Pearl Street. This will be a public bid. ODOT has approved 100% of the main sidewalk area.
