Ontario City Council met in regular session on October 4, 2023, in the Municipal Building with Council President Eddie Gallo presiding. The meeting opened at 7:03 p.m. with the Pledge of Allegiance.

Present during roll call were Council members Kyle Webb, Josh Bradley, Sherry Branham, Rose Feagin, Council President Eddie Gallo, Mayor Randy Hutchinson, Law Director Andrew Medwid, and Service-Safety Director Kris Knapp.

The minutes of the regular Council meeting of September 20, 2023 were presented for approval. Hearing no corrections, the minutes were approved as presented.

Richland County Executive Director of Children Services Nikki Harless and Community Engagement Specialist Brigitte Coles came forward to share information about the upcoming Children Services Replacement Levy.

MAYOR'S REPORT

Mayor Hutchinson said Petty Farms offered to donate their time and material for repairs needed to the soccer fields. Council members were grateful for their offer and approved the donation.

SERVICE-SAFETY DIRECTOR'S REPORT

Director Knapp reported:

- The city's additional cyber insurance coverage is sufficient.
- The damage to the Route 30/Home Road bridge will be repaired by ODOT, at no cost to the city.
- Once it rains on the test sealcoat on Jaqueline Court to see if there are any negative effects, they will determine if the sealcoat can be used on parking lots in the city parks.
- Strategic Turf will aerate the soccer fields after the season ends.
- Administration approved a 2-year contract for the city's (not residential) gas aggregation rate at \$.69 per ccf.
- Menards remains under a stop work order on their storage unit project due to complaints on storm water run-off and dust.
