November 1, 2023

Ontario City Council met in regular session on November 1, 2023, in the Municipal Building with Council President Eddie Gallo presiding. The meeting opened at 7:24 p.m. President Gallo asked Veterans Ashland Butcher and Marc Vanerio to lead the Pledge of Allegiance.

Present during roll call were Council members Troy Sapp, Dave Rehfeldt, Kyle Webb, Sherry Branham-Fonner, Rose Feagin, Nathan Sunderland, Council President Eddie Gallo, Mayor Randy Hutchinson, Law Director Andrew Medwid, Service-Safety Director Kris Knapp, and Clerk of Council Cathy VanAuker.

The minutes of the regular Council meeting of October 18, 2023 were presented for approval. Hearing no corrections, the minutes were approved as presented.

President Gallo presented the first Ontario military banner, honoring Army Veteran Ashland Butcher. In the spring, military banners will be displayed along Lex-Springmill Road.

COMMITTEE REPORTS

Mr. Sapp scheduled a Parks Committee meeting on November 15, 2023 at 5:00 p.m. One topic of discussion will be moving the VFW tank to Marshall Park and the exact location of where to place the tank. This information is needed to complete the paperwork.

Mr. Rehfeldt said there will be a Finance Committee of the Whole meeting to discuss the budget on November 15, 2023 at 5:30 p.m. He will meet with the Mayor on Friday to discuss specific line items.

Mrs. Branham-Fonner said the Personnel Committee will meet immediately following the Council meeting on November 15, 2023 to discuss Ordinance 23-04.

Ms. Feagin announced a Streets Committee meeting on December 13, 2023 at 5:30 p.m.

MAYOR'S REPORT

SERVICE-SAFETY DIRECTOR'S REPORT

Director Knapp provided updates:

- During Caucus, K.E. McCartney Engineer Mar Rufener explained the Menards Stop Work Order. Menards representatives will be invited to the next Council meeting.
- There have been two water breaks in 24 hours. The break on S. Lex-Springmill is the waterline that will be replaced. The second break on N. Lex-Springmill is in the middle of the road with 4 inches of asphalt and 6 inches of concrete.
- The lowest bid on the S. Lex-Springmill waterline project was \$100,000 less than the projected cost of the project. At the next meeting he will ask Council for a recommendation to award the bid.
- Director Knapp attended ODOT training on how to obtain project funding. He will present a couple of grant opportunities at the Parks Committee meeting. The grants they apply for now won't become available until 2025-2027.
- November 17th is the final day for leaf pick-up, contingent upon weather.
- The salt shed is finished. Salt will be stored in the shed once the signed documents are received.

PUBLIC COMMENTARY

Craig Hunt, 3680 Park Avenue West, asked for more clarification on how the Menards Stop Work Order can be lifted when there are ongoing problems that need fixed. Law Director Medwid explained the Stop Work Order was for specific items, the plan approval is for additional items beyond what is listed in the work order.

Robin Vanerio, 1883 Walker Lake Road, would like Menards to be responsible for correcting the issues with the neighboring properties and was opposed that the homeowners would need to hire an attorney to file a civil suit against something that should have been controlled from the beginning.

President Gallo said he wanted representatives from Menards to attend the next Council meeting to further discuss the ongoing situation the homeowners are experiencing.

PUBLIC HEARING

At 7:52 p.m. the public hearing was opened to add Section 1145.39 Construction Hours to the City Zoning Code.
