Ontario City Council met in regular session on March 20, 2024, in the Municipal Building with Council President Eddie Gallo presiding. The meeting opened at 7:05 p.m.

President Gallo introduced Ben Leighty to lead the Pledge of Allegiance. Mr. Leighty graduated from Ontario High School, Mt. Vernon Nazarene University, and in 1993 enlisted in the Air Force. He was stationed in Alaska with the 90th Fighter Squadron, was deployed to Germany, Korea, Kuwait, Iraq, Afghanistan, Qatar, Uzbekistan and Antarctica, and was a Crew Chief for F-15s and C-130s at the 179th Air Wing.

Present during roll call were Council members Troy Sapp, Dave Rehfeldt, Kyle Webb, Josh Bradley, Sherry Branham-Fonner, Nathan Sunderland, Council President Eddie Gallo, Mayor Randy Hutchinson, Law Director Andrew Medwid, Service-Safety Director Kris Knapp, and Clerk of Council Cathy VanAuker.

The minutes of the regular Council meeting of March 6, 2024, were presented for approval. Hearing no corrections, the minutes were approved as presented.

COMMITTEE REPORTS

Mr. Webb scheduled a Utilities Committee meeting on April 3, 2024 at 5:15 p.m.

Mrs. Branham-Fonner said the Personnel Committee met this evening in executive session.

MAYOR'S REPORT

Mayor Hutchinson said the Comprehensive Plan is on the website and Facebook. There is a QR code that can be scanned. They would like as many people as possible to take this second survey.

On April 8th, for the Eclipse, the Police Department is working 12-hour shifts, the Service Department will work regular hours, and the Administration Offices will be at minimum staffing. The Richland County Emergency Management Agency is predicting congested traffic, and there could be interruptions in cell service and internet accessibility due to the increased demand.

SERVICE-SAFETY DIRECTOR'S REPORT

Director Knapp reported that Menards contracted engineers to redraw the site's stormwater runoff and there should be an update next week to approve. The buildings are complete but will not open until they receive city approval. The debris is cleaned up in that area.
