

ORDINANCE NO. 24-08

AN ORDINANCE APPROVING THE EDITION AND INCLUSION OF CERTAIN ORDINANCES AS PARTS OF THE VARIOUS COMPONENT CODES OF THE CODIFIED ORDINANCES OF ONTARIO, OHIO, AND DECLARING AN EMERGENCY.

WHEREAS, various ordinances of a general and permanent nature have been passed which should be included in the Codified Ordinances of the City of Ontario, Ohio; and

WHEREAS, numerous sections in the Traffic and General Offenses Codes need to be updated so as to conform to enactments of the General Assembly;

WHEREAS, the codification of such ordinances, together with new matter to be adopted, the matters to be amended and those to be repealed, are before Council,

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF ONTARIO, OHIO, AS FOLLOWS:

SECTION 1. That the editing, arrangement and numbering or renumbering of the following ordinances and parts of ordinances are hereby approved as parts of the various component codes of the Codified Ordinances of Ontario, Ohio, so as to conform to the classification and numbering system of the Codified Ordinances, to-wit:
