Ontario City Council met in regular session on November 6, 2024, in the Municipal Building with Council President Eddie Gallo presiding. The meeting opened at 7:01 p.m. with the Pledge of Allegiance.

Present during roll call were Council members Troy Sapp, Dave Rehfeldt, Kyle Webb, Josh Bradley, Sherry Branham-Fonner, Rose Feagin, Nathan Sunderland, Council President Eddie Gallo, Mayor Kris Knapp, Law Director Andrew Medwid, Service-Safety Director Adam Gongwer, and Clerk of Council Cathy VanAuker.

The minutes of the regular Council meeting of October 16, 2024 were presented for approval. Hearing no corrections, the minutes were approved as presented.

COMMITTEE REPORTS

Mr. Sapp reported:

- OYS financials were submitted to the Mayor, and suggested OYS attend a Council meeting after the first of the year.
- December 5th at 5:45 p.m. will be the first annual golf cart Holiday Parade. Entries can be a golf cart, ATV, or side-by-side. This event will take place prior to the Christmas Tree Lighting and music by the high school band and choir.
- The Haunted Hallways was a big success.

Mr. Rehfeldt cancelled the November 8^{th} Finance Committee meeting, rescheduling on November 12^{th} from 11:30 a.m. -1:30 p.m. in the Mayor's Office, with a follow-up meeting on November 15^{th} at 9:00 a.m. The temporary budget is to get through March because capital planning isn't done until the first quarter. The temporary budget will be the operating budget without all of the capital projects. Any first quarter capital projects will be included in the temporary budget.

Mr. Bradley said Glen Grisdale of Reveille will present the Ontario Community Comprehensive Plan at the Economic Development Committee meeting on November 20, 2024, at 5:00 p.m.

Mrs. Branham-Fonner will meet with the Mayor next week then determine when the Personnel Committee will review the policy.

Mr. Sunderland said the Safety Committee met this evening and Chief Hill provided updates:

- The FLOCK camera systems helped to locate a couple of missing persons and a shooting suspect in a neighboring county.
- The Ticket Waiver program begins November 20th December 15th.
- Three speed limit signs were purchased and three more will be purchased next year.
- The Mayor and Director will meet with ODOT and the City of Mansfield on some traffic safety concerns.

MAYOR'S REPORT

Mayor Knapp reported:

• The Veterans banners will be taken down next week. Families will be contacted and will be able to pick up their banners if they want to keep them. In January, applications will be available for the new banners.

SERVICE-SAFETY DIRECTOR'S REPORT

Director Gongwer provided an update:

- Administration Offices will be closed Monday in observance of Veterans Day.
- Leaf pick-up will continue another two weeks. There isn't a schedule, crews are out almost every day.
