December 4, 2024

Ontario City Council met in regular session on December 4, 2024, in the Municipal Building with Council President Eddie Gallo presiding. The meeting opened at 7:11 p.m.

President Gallo introduced Steve Goulding to lead the Pledge of Allegiance. Mr. Goulding served in the Marine Corps. He was machine gunner, stationed in Guam, and was in the Mediterranean on the USS Inchon. Mr. Goulding and his wife are co-owners of Beyond Esthetics Med Spa in Ontario and both of their children are Ontario High School graduates.

Present during roll call were Council members Dave Rehfeldt, Kyle Webb, Josh Bradley, Sherry Branham-Fonner, Rose Feagin, Nathan Sunderland, Council President Eddie Gallo, Mayor Kris Knapp, Law Director Andrew Medwid, Service-Safety Director Adam Gongwer, and Clerk of Council Cathy VanAuker.

The minutes of the regular Council meeting of November 20, 2024 were presented for approval. Hearing no corrections, the minutes were approved as presented.

COMMITTEE REPORTS

Mr. Rehfeldt said the Finance Committee will meet on December 6, 2024 at 9:00 a.m. to discuss the temporary budget.

Director Gongwer responded to questions on the two projects in the Spring Village neighborhood.

- The sewer line replacement on Spring Village Lane should be completed by mid-February with final paving in the spring when asphalt is available. Residents will be notified when their driveway will be temporarily blocked during the project.
- The Victoria Court area sewer rehab, I/I reduction project, should start by the first of the year and end in April. They will place liners inside the sewer pipes.

Mr. Bradley reported the Economic Development Committee met earlier this evening. The Comprehensive Community Plan was discussed and they agreed it will go before Council to approve. Resolution 24-15 is on this evening's agenda. A quote will be requested from the same company for zoning updates. An MOU was introduced between the City and the Richland Community Development Group. The application for the Safe School Travel Plan was discussed.

Mr. Bradley scheduled an Economic Development Committee meeting on December 18, 2024, at 5:30 p.m.

Mrs. Branham-Fonner said the Personnel Committee met this evening in executive session, then voted to approve the changes discussed to the Wage Ordinance and for the Law Director to prepare legislation for the next meeting.
