December 18, 2024

Ontario City Council met in regular session on December 18, 2024, in the Municipal Building with Council President Eddie Gallo presiding. The meeting opened at 7:12 p.m. with Sgt. Barnhart leading the Pledge of Allegiance.

Present during roll call were Council members Troy Sapp, Dave Rehfeldt, Kyle Webb, Josh Bradley, Rose Feagin, Nathan Sunderland, Council President Eddie Gallo, Mayor Kris Knapp, Law Director Andrew Medwid, Service-Safety Director Adam Gongwer, Chief Tom Hill, and Clerk of Council Cathy VanAuker.

The minutes of the regular Council meeting of December 4, 2024 were presented for approval. Hearing no corrections, the minutes were approved as presented.

COMMITTEE REPORTS

Mr. Sapp will contact OYS to prepare a report for the beginning of the year. The golf cart/side-by-side parade was a success and will be expanded next year. Ontario Giving was a great event where Ontario High School student Bodpegn Miller, who recently signed with OSU football, signed autographs, and the Miss Ontario Court participated.

Mr. Webb reported the Personnel Committee meeting this evening was held in executive session. Committee members agreed to take Ordinance 24-10, Personnel Policy and Procedure Manual, off the table to vote on this evening.

Mr. Bradley said the Economic Development Committee meeting was held in executive session this evening.

Mr. Bradley scheduled an Economic Development Committee meeting for January 8, 2025 at 5:30 p.m.

MAYOR'S REPORT

Mayor Knapp reported:

- Mr. Webb was acknowledged for setting up the new iPads that Council received this evening.
- The 2025 temporary budget includes funds to upgrade the Council Chambers with tv's.
- The Community Room was recently painted and new flooring installed. The Service Department employees wiped off all the cables and fixed the blinds.
- RCDG will assist in organizing the Community Improvement Corporation (CIC). The Law Director will prepare legislation for the next agenda.
- Mansfield has a contract with Richland Public Health dated 1986, and Ontario has a contract with Richland Public Health dated January 3, 2002. The goal is to merge the contracts. Ontario appoints two members to the Board.
- Mr. Greg Franklin is renovating the previous Oswalt Furniture Building, 557 Home Road, into the Loft and Rails Event Center. He is requesting transfer of a liquor license to this location. Events serving alcohol to over 100 guests will require a police officer on the premises.
- Mr. Singh is requesting transfer of a liquor license to sell wine at the OnWay gas station at 3636 PAW.
- Mayor Knapp read a request from a Springfield Township Trustee to consider not charging the Fire Stations for water usage. Discussion will continue at a later time when the Township Trustees and City Council members meet.

POLICE DEPARTMENT'S REPORT

Chief Hill thanked the Fire Department for all they do and how well the Police and Fire Departments work together.

On December 20th a special event will be held in the Community Room for a 4 year-old boy battling a brain tumor. He will be sworn in as honorary police officer # 127. Santa Claus will be there for the children.

SERVICE-SAFETY DIRECTOR'S REPORT

Director Gongwer provided an update on the Hagerman light display. Interior lights were used on the displays. When moisture gets in the lights and one light goes out, the entire strand goes out. The City must comply to more stringent regulations when hooking up the lights on public property than when they were displayed on private property. Next year, exterior LED lights will be on the displays and permanent electricity will be installed.

Mr. Webb moved to adopt Ordinance No. 24-10, second by Mr. Rehfeldt. Six members cast their votes Aye, zero Nay, and Ordinance No. 24-10 was adopted.
