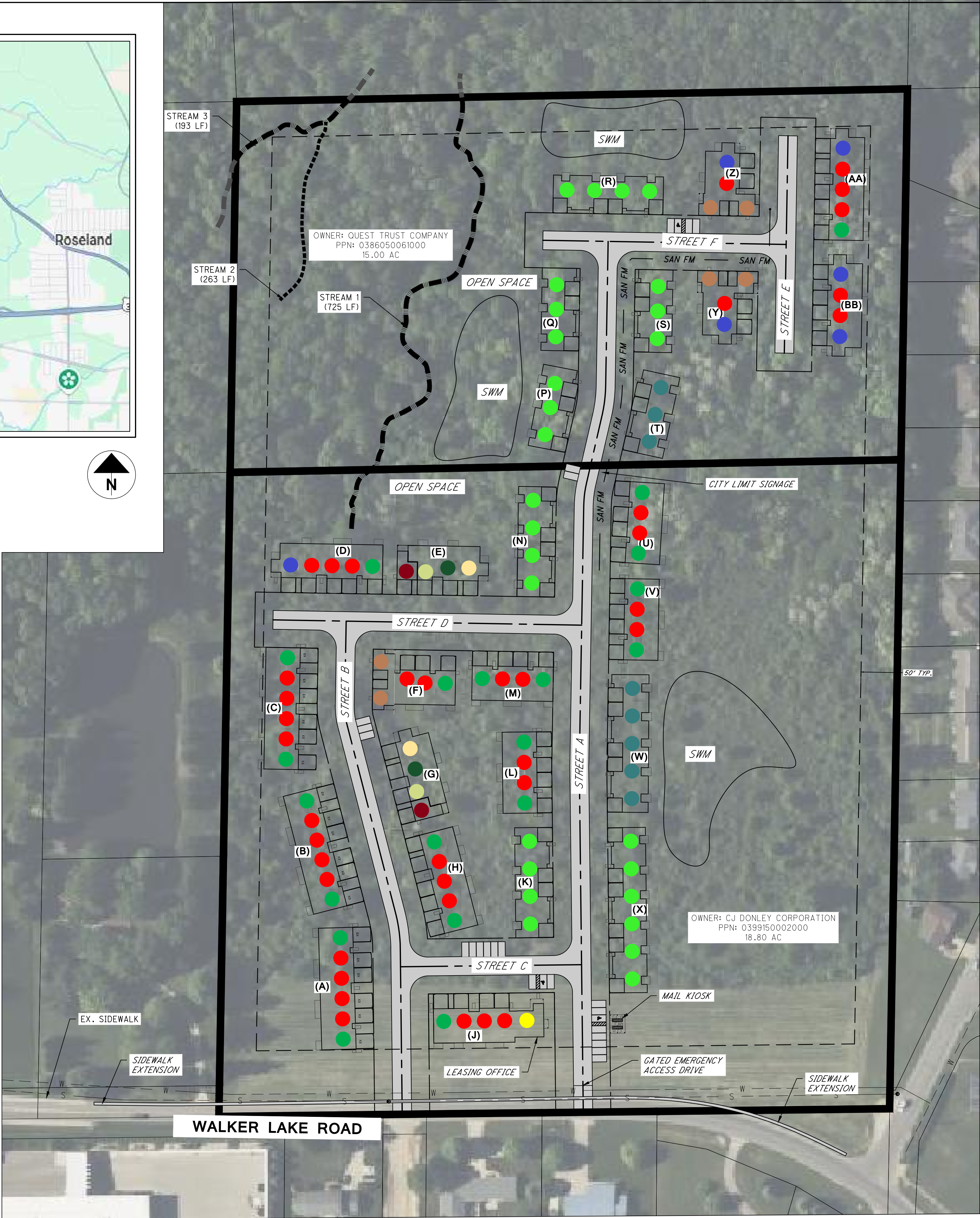
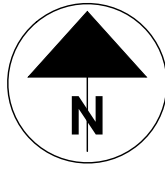




LOCATION MAP
